

Report on the 2021 YU Campus Climate Survey

Fall 2021

The Campus Climate Survey is designed by Yeshiva University Campus Climate Survey Committee to ascertain general awareness and knowledge of the University's prevention and response to sexual assault. In Fall 2021, all YU undergraduate, graduate, and professional school students were invited to take the survey. The survey is anonymous and confidential. Of the total of 4,788 YU students, 825 students responded to the survey, resulting in a response rate of 17.2%. Following are the results of the survey.
