Yeshiva University's (YU) Master of Speech-Language Pathology (SLP) program is scheduled for a site visit from its accrediting body, the Council on Academic Accreditation in Audiology and Speech-Language Pathology (CAA). In accordance with CAA's Public Comment Policy and Procedures, the CAA is seeking public comment as part of its review of YU's SLP program.

During the site visit, the Department of Speech-Language Pathology will host a public meeting in which we invite anyone interested—alumni, students, faculty, clinical supervisors, community members—to offer questions, comments, or concerns regarding YU's graduate SLP program.

We invite you to participate by providing your feedback about the SLP program, which has an award of accredited status. You can submit comments in one of two ways:

- 1. Register to attend the public meeting on Wednesday, May 22, 2024, at 11:15 AM to be held via Zoom.
- Per CAA guidelines, individuals may submit written comments prior to the accreditation site visit. Written comments are due to the Accreditation Office no later than 15 days prior to Wednesday, May 22, 2024, visit. Comments received after this time will not be forwarded to the site visit team for consideration during the accreditation review, in accordance with the procedures specified in the Accreditation Handbook.

### All questions, comments, or concerns must:

- Relate to the program's compliance with the current Standards for Accreditation
- · Identify the specific program seeking continued accreditation with the CAA
- All written testimony—including comments faxed or submitted as e-mail attachments—must include the commenter's name, address and telephone contact information and the commenter's relationship to the program in order for Accreditation staff to verify the source of the testimony. All comments must be signed.

Please note: Comments that do not meet these requirements will not be considered, and the individual or group commenting will be notified.
